**MEMORANDUM**

1. The appointment of **Dr. Subramanian P.** to the post of **Head, Division of Crop Production, ICAR-Central Plantation Crops Research Institute, Kasaragod** will be on tenure basis for a period of five years from his date of joining of the post or until further orders, whichever is earlier.
2. The scale of pay of the post is pay level-14 (Rs.1,44,200-Rs.2,18,200/-) with rationalized entry pay of Rs.1,44,200/-. His pay will be regulated according to the relevant rules.
3. His Headquarters will be at **ICAR-Central Plantation Crops Research Institute, Kasaragod** for the present but he will be liable to be transferred anywhere in India.
4. Other conditions of service will be governed by the relevant rules/orders/ staff regulations which may be issued by the ICAR from time to time. The appointment is subject to A.R.S. Rules, Rules & Bye-Laws and Regulations of ICAR society.
5. After completion of his/her tenure or until further orders, whichever is earlier, he can be posted in any ICAR Institute as per requirement of the Council, subject to the availability of the vacancy in the respective cadre/discipline.
6. If any declaration given or information furnished by him proves to be false or he is found to have willfully suppressed any material information, she will be liable to removal from service and such other action as may be deemed necessary.
7. **Dr. Subramanian P.** may please inform the undersigned of his acceptance of this offer of appointment and he may join the post of **Head, Division of Crop Production, ICAR-Central Plantation Crops Research Institute, Kasaragod** at the earliest possible.
