Smt. Reetha M, Asst. Admin. Officer (Audit & Accounts), ICAR-CPCRI, Kasaragod welcomed the pensioners and presented the action taken based on the decision of the last meeting held on 29.12.2020 at ICAR-CPCRI, Kasaragod through Video Conference. She also briefed the importance of the meeting with Pensioners/Family pensioners to resolve the issues and exchange of new orders to the Pensioners/Family pensioners. A Total number of twenty two (22) pensioners were attended the video conference.

1. Mr. M.S Antony, Assistant(Retd) has pointed out that medical re-imburement bills are kept pending for a long time for settlement. The point discussed with DDO/AAO Bills and it was decided that a remedial action will be taken at the earliest. Shri. Antony also raised a point regarding pending of medical bills due to the absence of Medical officer at Kasaragod. He asked whether we can authorise store in-charge to sign the medical bill in the absence of Medical Officer.

2. Mr. G. Alagu Mari Muthu, Retired Admin. Officer requested, for implementation of cashless facilities with empanelled hospital for medical treatment. The modalities for implementation may be discussed with ICAR Institutes who have started implementing it.(Eg:- NAARM, Hyderabad). FAO raised the difficulties in the recovery of excess/ineligible amount if any, from the Pensioners. Shri. G. Alagu Mari Muthu has raised one more point regarding consultation with doctor through video call facility. These points will be forwarded to ICAR HQ, through proper channel for approval/implementation.

3. Dr. R.V. Nair, Principal Scientist, has raised a point against pending of medical bills and had submitted a representation to Regional Station, Kayamkulam regarding this. After examining the representation, the problems will be sort-out at the earliest and to be informed to the affected pensioner.

4. Shri. K.G.Bhageerath, AAO, R.S, Kayamkulam conveyed the point raised by Dr. Chandrika Mohan, Principal Scientist (Retd) that the pensioner has not even received their original PPO till date.

FAO, ICAR-CPCRI, Kasaragod replied that the Pensioner may contact CPPC Thiruvananthapuram through pension disbursing branch of SBI.

5. Shri. K.V Kunhikannan, Asst. Admin Officer(Retd), ICAR-CPCRI, Kasaragod, has raised a point about restoring of commutation amount of Smt. P.K. Devayani, Private Secretary (Retd). FAO, ICAR-CPCRI, Kasaragod very clearly briefed about this point that, revision of pay and pension of Smt P.K. Devayani has been done in four schedule due to revision in Pay and based on 6<sup>th</sup> CPC Pay Scale. Smt. P.K Devayani was retired in the month of October 2006 and the same month CVP credited to the pensioner and started to deduct the commuted amount for fifteen years and restored in September 2021. Consequently, revision of Pay/Pension done due to increment/fixation of pay as per 6<sup>th</sup> CPC. Accordingly she has given CVP in three steps and commuted amount also to be recovered from the pensioner upto the restoration period. Shri. K V Kunhikannan is satisfied with the reply and settled the point.

6. Shri. K.N.Pankajakshan, Technical Asst(Retd), ICAR-CPCRI, Kasaragod, has raised the point that he has not received the Pension book from the pension disbursing branch. FAO, ICAR-CPCRI, Kasaragod assured in the meeting to enquire about this.

7. Dr. Thomas Mathew, has requested to include Chethipuzha St. Thomas hospital, which is a multi speciality hospital as empanelled hospital of ICAR for medical treatment. The Pensioner will sent a representation via email to Director of this Institute. After receiving mail we will send a request letter to ICAR for approval.

8. Shri. Jinappa Moolya, Asst. Admin. Officer(Retd) has raised a point that he has submitted Private hospital medical bill to Regional Station, Vittal two years ago . He has not yet received any reply to it. DDO, Kasaragod replied that no such bill is pending with CPCRI, Kasaragod. Head, Regional Station, Vittal replied that they will locate the bill at their station itself and will report it to the pensioner.

9. Shri. Vishwanathan, Technical Officer-Driver(T5), has requested to held Pension Adalat in offline mode at RC, Kidu Station twice a year since most of the pensioners belong to SSS categories and are not in a position to attend online meeting. FAO, Kasaragod replied that, the matter will be discussed with Director and informed later . He has also pointed out the delay in issue of Identity Card to the Pensioners. AAO stores replied that it is under process and we have already issued ID for many of the pensioners in first out first in mode.

10. Smt. Reetha. M, Asst. Admin. Officer,(Audit & Accounts), requested all pensioners to inform the office about the changes in residential address or bank address if any. Also, Telephone number must be reflected in any kind of communication with this institute.
