Shri. M Ravindran, Assistant Administrative Officer (Audit & Accounts) ICAR-CPCRI, Kasaragod welcomed the Pensioners, all Officers and staff of ICAR-IISR, Calicut, Regional Stations & Research Centres of CPCRI, Kasaragod. A total number of 23 pensioners/officials have attended Pension Adalat through video conference. Shri. Ram Avtar Parashar, Chief Finance & Accounts Officer, ICAR-CPCRI, Kasaragod, chaired the meeting and presented the follow up action on the decisions of the last meeting held on 05th May 2022 at ICAR-CPCRI, Kasaragod through video conference. He briefed about the latest orders issued regarding medical treatment at empanelled hospitals and also briefed about facilities of Inpatient treatment cashless payment of staff/pensioners based on CGHS rules.

- Dr. R.V Nair, HoD, Crop Improvement (Retd.), aggrieved that in cases where PMO refer the patients (Pensioners) to empanelled hospital situated in far off place from their residence, it causes heavy expense to the pensioner. Hence requested to allow travelling expense claims along with medical bills. Chief Finance and Accounts Officer, has agreed to consider such cases on its merit.
- Dr. R V Nair, HoD, Crop Improvement (Retd.) requested to conduct Pension Adalat (offline mode) in Regional Station Kayamkulam twice a year. Chief Finance and Accounts Officer has stated that Pension Adalat will be organized twice a year at the Institute, irrespective of Regional Station or Research Centre.
- Shri. G A M Muthu, AAO (Retd.) asked about the progress in cashless medical treatment a) facilities for the pensioner which is implemented by some places/organizations two years ago. Chief Finance and Accounts Officer has explained the merits and demerits of the facility in detail. He opined that the facility would be very helpful to the permanent staff & pensioners if executed in future. For executing this facility initially, there is a need of an agreement (MoU) to be signed with the recognized hospital as per CS(MA)/CGHS rules and regulations. However, the point was agreed to for further examination.
- b) Shri G A M Muthu, Administrative Officer (Retd.), ICAR-CPCRI, Kasaragod also raised a point regarding crediting of DR arrears before issuing ICAR endorsement letter. Chief Finance and Accounts Officer clarified that DR arrears will be credited only after getting an endorsement letter from the Council.

Shri. Thomas Mathew, Technical Officer (Retd.), ICAR-CPCRI, Regional Station. Kayamkulam requested to include Chethipuzha St. Thomas Hospital, which is a multi-specialty hospital in the empanelled hospital list of ICAR. Chief Finance and Accounts Officer suggested to submit a proposal through Regional Station, Kayamkulam for recognition of the hospital by ICAR.

 Shri. T.E. Janardhanan, Senior Administrative Officer, ICAR-IISR, Calicut, proposed to organize Pension Adalat at ICAR-IISR, Calicut also. The proposal was agreed to.

Dr. Arun Kumar Sit, Scientist-in-Charge, ICAR-CPCRI, RC, Mohitnagar, raised a point that they are experiencing delay in releasing monthly pension to the Pensioners of Mohitnagar on the part of the Bank, Chief Finance and Accounts Officer agreed to take up the point with Chief Manager, CPPC, New Jalpaiguri to avoid delay in crediting of pension timely.

It is decided to hold the next meeting with Pensioners/Family Pensioners in offline mode. Venue of the Meeting will be scheduled in due course.

The meeting came to a close at 12.10 PM with the vote of thanks by Shri. P. Krishnan Kumar, AO, ICAR-CPCRI, Kasaragod.
