SCOPE OF WORK, ELIGIBILITY CRITERIA AND TERMS AND CONDITIONS:

Scope of work:

Disposal of obsolete metal scrap items, which are declared obsolete/ unserviceable/ irreparable/broken/scraps. Detailed list of unserviceable and obsolete metal scrap of ICAR-CPCRI, Kasaragod proposed to be disposed is as under:-

NOTE:- Reserve or Base price of the above tender is Rs. 4,50,000/- i.e. (Rupees Four lakh fifty thousand only)

THE ITEMS SHALL BE SOLD TO THE BIDDER WHO WILL QUOTE THE CONSOLIDATED HIGHEST RATES. THE BIDS ARE INVITED FOR THE WHOLE LOT (i.e. ALL THE ITEMS CONTAINED IN THE LIST OF OBSOLETE ITEMS AS DETAILED ABOVE AS A WHOLE) AND NO BID WOULD BE ACCEPTED FOR ANY PART OF THE SAME.

Eligibility Criteria:

1. The bidder shall deposit Rs. **20,000/-** (Rupees **Twenty thousand** only) as EMD (Earnest Money Deposit) in the form of NEFT (Acct No: 30043174688, IFSC-SBIN0010560, **Bank-SBI, Branch-CPCRI Campus, Kasaragod**) / DD drawn in favour of **ICAR Unit, ICAR-CPCRI Kasaragod** in a separate envelope and same (in original) will be submitted in Store Section, ICAR-CPCRI, Kasaragod before the cutoff date of submission of online Bid on GeM. EMD of the unsuccessful bidder shall be returned without interest at the earliest after the award of the sale order to H-1 Bidder.
2. Copy of PAN Card and GST either in the name of the proprietor/owner/firm/company is required to be uploaded along with the bid on the GeM Portal. The document to be uploaded should be legible. In case the uploaded documents are not readable, the bid cannot be examined and the bid can be rejected, thereby cancelling the bid of that firm.

Basis of Selection:

The basis of selection of vendors for each item shall be as under:

- (a) Auction shall be started with start bid prices as communicated.
- (b) The party emerging as highest bidder in the auction (in totality) shall be designated as final H1.

Terms of Payment:-

Full payment will have to be made in advance in favour of ICAR Unit, CPCRI, Kasaragod and within 05 days of intimation/call-up by means of a NEFT transfer/Bank Draft/Pay Order. In case of payment by cheque, delivery of materials will be given only after the cheque has been credited to ICAR Unit, CPCRI, Kasaragod. Failure to comply shall make the Security Deposit liable for forfeiture.

Note:- The H1 bidder will have to deposit the applicable GST amount in advance on the basis of Reverse Charge Mechanism in the relevant Government Account on behalf of ICAR-CPCRI, Kasaragod. The receipt of the GST deposited will have to be submitted by H1 bidder in ICAR-CPCRI, Kasaragod.

Risk Purchase Clause:-

If any vendor fails to uplift the material within 10 days, the seller reserves the right to sell the disposable material to any other alternate sources at the risk of failed vendor and the differential cost will be recovered from them and the EMD will be forfeited.

Terms and Conditions:

1. The Unserviceable items will be available on Auction "As is where is" basis and on one time pickup. **The Unserviceable items can be inspected by the interested parties on any working days between 10:00 Hrs to 16:00hrs (Monday to Friday) by contacting the Store Section, ICAR-CPCRI, Kasaragod.** No request for inspection after submission of the bid will be accepted.
2. The bid shall remain valid for 45 days after the date of bid opening. If any bidder withdraws his/ her bid before the said-period, Director, ICAR-CPRI, Kasaragod shall without prejudice to any other right or remedy, be at liberty to forfeit the Bid Security absolutely.
3. Conditional bid shall not be entertained.
4. Evaluation criteria: The successful bidder will be the one which offer the highest total rate for the entire lot of scrap as detailed above, no part lifting of the items shall be allowed.

5. All the bidders shall fill the details of EMD on GeM if the option is available before submission of bids.
6. **Rates should be quoted inclusive of all taxes, freight & labour charges, any other charges, etc. in the auction on GeM. (After Quoting the rate on GeM the bidder must send a mail showing breakup details of Quote price) storeskasaragod@yahoo.in**
7. The undersigned will not entertain any claim for damage done by the way of theft, fire or any other unforeseen calamity after realizing full payment against the Unserviceable e-Waste Material/items.
8. The Unserviceable materials/item is to be lifted up within 10 days on the issue of letter of Offer/Intimation on making full payment in favor of ICAR Unit, CPCRI, Kasaragod. Otherwise the EMD money deposited will stand forfeited and the offer shall be awarded to the next eligible bidder.
9. The successful bidder has to lift all the Unserviceable items at their own cost. The bidder shall be responsible for the transport of e-Waste items from ICAR-CPCRI, Kasaragod and bear the cost of same.
10. The bid received without EMD (in original) will be liable for rejection.
11. The undersigned reserves the right to accept or reject any offer either part or whole without assigning any reason.
12. The details of Unserviceable scraps to be auctioned is attached as **Annexure-I**.
13. At any time ICAR-CPCRI, Kasaragod may modify the bidding document by amendment thereto. The amendment will be notified on ICAR-CPCRI Website only, which will be binding on bidders. Bidders should regularly visit the website <https://cpcri.icar.gov.in> to keep themselves updated.
