



SCOPE OF WORK, ELIGIBLITY CRITERIA AND TERMS AND CONDITIONS: Scope of work:

To sell 25000 nos of matured coconut through E-Auction:-

<u>NOTE:-</u> Reserve or Base price of the above tender is Rs. 2,80,000/- (Rupees Two Lakh Eighty thousand only) @ Rs.11.20 per matured coconut (Exclusive of GST).

THE ITEMS SHALL BE SOLD TO THE BIDDER WHO WILL QUOTE THE CONSOLIDATED HIGHEST RATES. THE BIDS ARE INVITED FOR THE WHOLE LOT AND NO BID WOULD BE ACCEPTED FOR ANY PART OF THE SAME.

Eligibility Criteria:

1. The bidder shall deposit Rs. **50,000**/- (Rupees **Fifty thousand** only) as EMD (Earnest Money Deposit) in the form of Demand Draft drawn in favour of **ICAR Unit, CPCRI Kasaragod** in a separate envelope and same (in original) will be submitted in Store Section, ICAR-CPCRI, Kasaragod (copy of the same should be uploaded in GeM) before the cut off date of submission of online Bid on GeM. EMD of the unsuccessful bidder shall be returned without interestat the earliest after the award of the sale order to H-1 Bidder.

2. Copy of PAN and ADHAAR Card in the name of the proprietor/owner/firm/company is required to be uploaded along with the bid on the GeM Portal. The document uploaded should be legible. In case the uploaded documents are not readable, the same cannot be examined and the bid can be rejected, thereby cancelling the bid of that firm/individual.

Basis of Selection:

The basis of selection of vendors shall be as under:

- (a) Auction shall be started with start bid prices as communicated.
- (b) The party emerging as highest bidder in the auction shall be designated as final H1.

Terms of Payment:-

Full payment will have to be made in advance in favour of ICAR Unit, CPCRI, Kasaragod online (Acct No: 30043174688, IFSC:SBIN0010560) within 05 days of intimation/call-up. In case of payment by cheque, delivery of materials will be given only after the cheque has been credited to ICAR Unit, CPCRI, Kasaragod. Failure to comply shall make the Security Deposit liable for forfeiture.

<u>Risk Purchase Clause</u>:-

If any vendor fails to uplift the auctioned matured coconuts within a week time, the seller reserves the right sell the coconuts to any other alternate sources at the risk of failed vendor and the differential cost will be recovered from them and the EMD will be forfeited.

Terms and Conditions:

- 1. The matured coconuts can be inspected by the interested parties on any working days between 09.30 Hrs to 16:30 hrs (Monday to Friday) by contacting the Farm Section, ICAR-CPCRI, Kasaragod. No request for inspection after submission of the bid will be accepted.
- 2. The bid shall remain valid for 30 days after the date of bid opening. If any bidder withdraws his/ her bid before the said-period, Director, ICAR-CPRI Kasaragod shall without prejudice to any other right or remedy, be at liberty to forfeit the Bid Security absolutely.
- 3. Conditional bid shall not be entertained.
- 4. Evaluation criteria: The successful bidder will be the one which offer the highest total rate for the entire lot of matured coconut as detailed above, no part lifting of the items shallbe allowed.
- 5. All the bidders shall fill the details of EMD on GeM if the option is available before submission of bids.
- 6. The undersigned will not entertain any claim for damage done by the way of theft, fire or any other unforeseen calamity after realizing full payment against the auctioned matured coconuts.
- 7. The bid received without EMD (in original) will be liable for rejection.
- 8. The Competent authority of ICAR-CPCRI Kasaragod reserves the right to accept or reject any offer without assigning any reason.
- 9. At any time ICAR-CPCRI Kasaragod may modify the bidding document by amendment thereto. The amendment will be notified on ICAR-CPCRI Website only, which will be binding on bidders. Bidders should regularly visit the website <u>https://cpcri.icar.gov.in</u> to keep themselves updated.
