Online Bids are invited by The Director, ICAR-CPCRI, Kasaragod through GeM for the **AUCTION SALE OF MATURED, PUNY & MICRO PUNY COCONUTS ON AS & WHERE BASIS** from the eligible interested bidders as per the details mentioned below.

The bids will be received online through GeM with due approval of the Competent Authority of this Institute and shall be opened as per Standard Operating Procedures(SOP) of GeM.

**SCOPE OF WORK, ELIGIBILITY CRITERIA AND TERMS AND CONDITIONS:**

**I. Scope of work:**

To sell coconuts through E-Auction as furnished below:-

**II. Eligibility Criteria:**

1. The bidder shall deposit the EMD (Earnest Money Deposit) amount as mentioned at above in Scope of Work. The EMD should be in the form of Demand Draft drawn in favour of ICAR Unit, CPCRI Kasaragod in a separate envelope and same (in original) to be submitted to the Purchase and Inventory Management Section, ICAR-CPCRI,

Kasaragod (copy of the same should be uploaded in GeM) before the cutoff date of submission of online Bid on GeM. EMD of the unsuccessful bidder shall be returned without interest at the earliest after the award of the sale order to H-1 Bidder.

2. **Copy of PAN and AADHAAR Card in the name of the proprietor/owner/firm/company** is required to be uploaded along with the bid on the GeM Portal. The document uploaded should be legible. In case the uploaded documents are not readable, the same cannot be examined and the bid will be rejected, thereby cancelling the bid of that firm/individual.

### **Basis of Selection:**

The basis of selection of vendors shall be as under:

- (a) Auction shall be started with Reserve price.
- (b) The party emerging as highest bidder in the auction shall be designated as final H1.

### **Terms of Payment:-**

**Full payment will have to be made in advance** in favor of **ICAR Unit, CPCRI, Kasaragod** through online (Acct No: 30043174688, IFSC:SBIN0010560) within 05 days of intimation/call-up. In case of payment by cheque, delivery of materials will be given only after the cheque has been credited to ICAR Unit, CPCRI, Kasaragod. Failure to comply shall make the Security Deposit liable for forfeiture.

### **Risk Purchase Clause:-**

If any vendor fails to uplift the auctioned coconuts within a week time, the seller reserves the right to sell the coconuts to any other alternate sources at the risk of failed vendor and the differential cost will be recovered from them and the EMD will be forfeited.

### **III. Terms and Conditions:**

1. The successful bidder has to lift the auctioned Coconuts **ON AS & WHERE BASIS** within the stipulated time limit, else the EMD will be forfeited.
2. **The coconuts can be inspected by the interested parties on any working days between 09.30 Hrs to 16:30 hrs (Monday to Friday) by contacting the Farm Section, (Shri. Krishnan Nair K, TO - Farm Section – 9446777895) ICAR-CPCRI, Kasaragod.** No request for inspection after submission of the bid will be accepted.
3. If the H1 price quoted by the bidder is below the Subject to Approval (STA) limit, i.e., 1% of the Reserve Price, the GeM will automatically mark the H1 Bid as REJECTED and the H1 bidder will be no longer an H1 Bidder.
4. The bid shall remain valid for 30 days after the date of bid opening. If any bidder withdraws his/ her bid before the said-period, Director, ICAR-CPRI Kasaragod shall without prejudice to any other right or remedy, be at liberty to forfeit the Bid Security absolutely.
5. Conditional bid shall not be entertained.
6. Evaluation criteria: The successful bidder will be the one which offer the highest total rate for the entire lot of matured coconut as detailed above, no part lifting of the items shall be allowed.
7. All the bidders shall fill the details of EMD on GeM if the option is available before submission of bids.
8. The undersigned will not entertain any claim for damage done by the way of theft, fire or any other unforeseen calamity after realizing full payment against the auctioned matured coconuts.
9. The bid received without EMD (in original) will be liable for rejection.
10. The Competent authority of ICAR-CPCRI Kasaragod reserves the right to accept or reject any offer without assigning any reason.
11. At any time ICAR-CPCRI Kasaragod may modify the bidding document by amendment thereto. The amendment will be notified on ICAR-CPCRI Website only, which will be binding on bidders. Bidders should regularly visit the website <https://cpcri.icar.gov.in> to keep themselves updated.
