

Sealed tenders along with **EMD of Rs.60,000/-** by DD drawn in favour of "ICAR Unit, CPCRI, RS, Vittal" on Canara Bank, Vittal should reach the undersigned in separate envelopes by **11.00AM on 15.09.2022**. Those who have PAN Card,GST registration, APMC licence and remit EMD can only submit the sealed tender/participate in the Public Auction. **Public auction will commence at 11.30 AM on 15.09.2022** and the tenders will be opened after conclusion of the auction process. **The EMD will be refunded to the unsuccessful bidders within 15 days of the auction. The successful bidder will have to pay 10% of the bid amount immediately after the auction** on confirmation and the balance amount in full with GST @5% within 15 days after clearing the APMC tax @0.5% etc. to the concerned department in addition to the bid amount, failing which the EMD and 10% of the bid amount will be forfeited and auction will be treated as cancelled.
