4. At least 35,000 Nos. Arecanut seed nut from mother palm may be taken by the office from harvested arecanut. The rate for the remaining raw arecanut may be quoted **Per Kg basis**. All works such as harvesting, transportation and weighing should be carried out by the party at his own cost.
5. The tender with the maximum rate will be accepted
6. In case of failure to complete the work satisfactorily, the EMD amount will be liable forfeited.
7. Care should be taken to avoid any damage to new bunch/flower of Arecanut palms and Intercropping etc. If happen any said incidents contractor will liable to compensate for that.
