The successful bidder will have to pay 10% of the bid amount immediately after the auction** on confirmation and the balance amount in full with GST @5% within 15 days after clearing the APMC tax @0.5% etc. to the concerned department in addition to the bid amount, failing which the EMD and 10% of the bid amount will be forfeited and auction will be treated as cancelled.
