Para: 19 Irregular filling up the post of JTA (T-1) by promotion

On scrutiny of file No. 4(13)/2008-Estt, it is observed that the post of T-1 (Plumber) re-designated as T-1(JTA)(Field/Farm Technician) in the Institute. A committee constituted for fill up the vacancy under promotion quota reserved for SSS within the ratio of 331/3. After it's meeting held on 29.6.2010, the committee selected Sri. V. Radhakrishnan, SSS, CPCRI, Kasargod to the post of T-1(Junior Technical Assistant (UR) in the pay band of RS.5200-20200 +GP 2000 at CPCRI Regional Station, Vittal vide office order No.4(13)/2008- Estt. Dated 1.7.2010. In this context it is submitted that the post of plumber became vacant due to the retirement of Sh. M. Narayanan on 30.6.2007. As per the Council letter No.17-12/95- Estt.IV dated 20.8.1996. The post of plumber has to be treated as of dying type and no new posts should be filled in such designations.

Further, the post of plumber required to be filled up in supporting category only. After the retirement of Sh. Narayana on 30.6.2007, this post can not be re-designated as T-1 (JTA) (Filed/Farm Technician) as this post is of dying cadre. The Institute can not convert a non-existent post and filled up it without the approval of the Council.

Further a post which remained vacant for more than 3 years can not be filled up. The reason for irregular appoint of incumbent after re-designated the post as T-1 required to be furnished to the Council.
