BRIEF FACTS LEADING TO 1st APPEAL

The Appellant had submitted an application dated 23.03.2014, under the RTI Act, addressed to the PIO, CPCRI, Kasaragod. As per the acknowledgement issued dt. 20.03.2014(?) by Shri.MP Ramesh Kumar, PIO, the record date of receipt of the prescribed application is 26.03.2014. Thus, unless otherwise rejected for reasons specified, the information sought for ought to have been provided by the PIO by 25.04.2014 in terms of Section 7(1) of the RTI Act. Though over 40 days have passed by now, the information is still to be received. Thus the application is deemed to have been rejected by the PIO. Hence this statutory appeal.

RELIEF SOUGHT

The RTI Application of the Appellant in question now stands rejected by the PIO without assigning any reasons with an ulterior motive and thus acted in contravention of the RTI Act. Under the circumstance aforesaid, the statutory Appeal is filed before the FAA seeking remedial measures under his statutory jurisdiction under the RTI Act.


