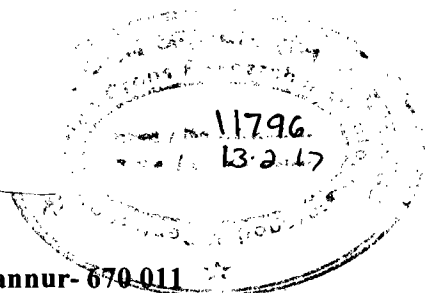





7. The grounds for appeal : Since the requisitioned information have not been provided within the specified time (i.e. by 08.02.2017) it is deemed to have been refused the request. **Here the principles of natural justice namely no one should be made a judge in his own cause is given a go bye.**
In the instant RTI query, entire information requisitioned by the Appellant incidentally pertains to the CPIO (Shri. Suresh Kumar) and thus duly exploiting the statutory position of CPIO, had acted with a malafide intent and suppressed the information sought under the RTI act. It is evident that the CPIO is misusing his


