With reference to your RTI application cited above, the following information are furnished:

4.	The family pension cases were delayed in view of the following reasons: The Dealing Assistant and the Section Officer in respect of pension cases was the same person due to the dearth of administrative staff. The file in respect of Mrs. Kallyani was returned from Accounts Section seeking the clarification as to the widow status of Mrs. Kallyani, as she become widow on 5.1.1985 and at the time of death of the pensioner, ie. on 10.1.1987, Mrs. Kallyani was not a dependent member. In the meantime the then Dealing Assistant/Section Officer was transferred to other section and then retired. The pending cases of family pension were not brought to the notice of the successor by the retired Dealing Assistant and the concerned file also was not handed over. The issue came to the notice when the son of Mrs. Kallyani reminded the issue. Immediately, the file was traced out and processed for authorizing the pension. Since the pension was sanctioned from the due date itself, there was no financial loss to the family pensioner. The delay was not intentional.
5.	All family pension cases were sanctioned by the Competent Authority.
6.	No. The family pension and the fixed medical allowance are sanctioned from the due date itself.


