**WHEREAS** Mr. C Mohanan, the appellant has sought the following information vide his RTI application dated 05.02.2019.

1	Whether approval of the competent authority in the ICAR was applied for and obtained in running the account captioned "Kisan Mela by the CPCRI and to provide copy of the ICAR approval so obtained
2	Whether the Kisan Mela Account for the period 2017-18 and 2018-19 have been / will be subjected to audit by the statutory auditors of the Institute/ICAR.

2. **WHEREAS** Mr. C Mohanan, has requested another information vide his RTI application dated 18.01.2019.

Sl.No.	Query
1	Bank Pass Book in respect of the A/c No. 37265705245 (Kisan mela, CPCRI, Kasaragod) – All Pages of the pass book containing all the transactions, including the page containing name of A/c holders, for period from the date of opening of the a/c and till the date 10.01.2019.


3. **WHEREAS** both aforesaid applications are similar in nature and hence the CPIO has replied to the effect that 'ICAR-CPCRI has not opened any account with A/c No.37265705245' vide two separate letters dated 11.03.2019.

4. **WHEREAS** aggrieved on the aforesaid replies, the applicant has preferred an appeal dated 05.03.2019 and 06.03.2019 respectively to the First Appellate Authority.
