3.	Whether the pension amount which I am entitled to get has been revised as per the 6 th CPC?	Yes. As per Order No. AA/Pension/704/08-Pension Dated 24.07.2017.
4.	If revised, on which date is revised and what is the actual monthly pension I am entitled to get as per the revision?	As per Order No. AA/Pension/704/08-Pension dated 24.07.2017, pension has been revised. Entitlement of actual monthly pension is Rs.4,700/- .
5.	Whether I am entitled to get any arrears of pension as per the revision is made?	All arrears as per 6 th CPC has already been paid.
