1(a)	Application of fertilizers /manure to arecanut palms. Recommended dose of fertilizer has to be applied to areca palms immediately after the first weeding. The fertilizer should be applied after opening the basin at 60-75 cm radius around the bole. Immediately after the application, it should be covered with the weeds heaped during the previous weeding and covered with soil which was removed during basin opening.	All arecanut palms	9500 palms	
1(b)	Farm Yard Manure(5kg/seedlings) and recommended dose of fertilizer has to be applied to arecanut seedlings immediately after the first weeding. The manure and fertilizer should be applied after cleaning the basin. Immediately after application, it should be covered with the weeds heaped during the previous weeding. FYM has to be transported from dairy unit of the institute. FYM & fertilizer will be provided by the institute	Newly planted arecanut seedlings	1050 seedlings	

Terms and conditions:

1. No implements will be provided departmentally, Tractor will be provided for transporting on payment basis whenever it is available
2. The work should be commenced forthwith upon issue of work order. All the work should be done as per the instructions of the TO/SIC/TA(Farm)
3. The rate may be quoted per palm/seedlings and it should be valid for a period of one year.
4. Security Deposit that is equal to 5% of the amount involved for the work to be deposited before commencement of work.
5. Payment will be made after satisfactory completion of work and production of bill duly certified by the concerned. 14 digits Bank Account Number with bank details should be provided for arranging e-payment.

6. Income tax as per rules will be recovered from the contract bill. Any other taxes imposed by the government will have to be borne by the contractor and will have to abide all the relevant labour/other laws of the land.
7. In case of failure to undertake the work satisfactorily, the security deposit made is liable to be forfeited.
