Sealed tenders are invited from registered and licensed contractors with PAN card holder for taking up the following work at this station on contract basis on the terms and conditions given below:



The work includes hand weeding/machine weeding and removing grasses /herbs & shrubs and cleaning the surrounding residential & non residential area of the institute campus. The work includes cutting all weeds/bushes up to ground level, transporting and applying to areca basins or as directed by SIC/TO(Farm). The work includes 3 or 4 rounds of weeding up to 31st March-2018. The first round should be done during August-September and second round during Nov-Dec and if required third round during Feb-2018. The second/third/fourth round may be done with machine weeding The rate for hand weeding (1st round) and machine weeding(1st & 1strd) may be quoted separately and it should be applicable up to march 2018.</p>	CPCRI Campus surrounding G.H,Type-I,II,III,IV& Head's quarter, Dispensary, Administration Block, Laboratory, Club, Canteen, Agrostology back side to Mohitnagar plot and down upto HDP in cocoa plot, nursery, society building upto Mangala plot, road sides from welcome board to lab, maingate to farm gate, from society to lab, surrounding areas of lab and slopy areas near lab etc.	5.0 ha

3. The rate may be quoted per hecter and it should be valid for a period up to March-2018.
4. Security Deposit that is equal to 5% of the amount involved for the work to be deposited before commencement of work.
