1.	Harvesting of matured cocoa pods from experimental/bulk trees in the campus. The work includes recording no. of healthy and diseased pods /tree during each harvest, loading, transporting to farm office, unloading and weighing of all diseased and health pods, sorting, removal and discarding all diseased/damaged pods, transporting seed pods to godown if required, breaking and removing wet beans from remaining healthy pods and handing over to farm office for sale. The work will be continued for one year starting from 01.04. 2017 to 31. 03. 2018 throughout the cropping season when and where pods are matured for harvest or as instructed by Pr.
