**The quotation should confirm to the following conditions:-**

3. It should include charges for oil servicing, yearly once, along with replacing of filter set, without the cost of lubricating oil (lub oil will be provided by the institute).
4. The charges for major overhauling, alternator rewinding and battery replacement need not be mentioned in the quotation.
