11. The items(s) ordered should be supplied in lot. Part supply will not be accepted. The right to accept or reject the quotation rests with the SIC, CPCRI, RC, Kidu.
12. TRANSIT INSURANCE: The purchaser will not pay separately for transit insurance and the supplier will be responsible until the entire stores contracted delivered in good condition at destination.
13. **EARNEST MONEY DEPOSIT @2%** of the quoted amount, if the quote exceeds Rs. 1,00,000/-, must be Deposited in cash or by demand draft drawn In favour of "ICAR, Unit CPCRI, Kasaragod" payable at SBI, CPCRI Branch, Kasaragod along with the quotation.

15. If the order value exceeds Rs. 1,00,000/- the successful tenderers shall have to furnish unconditional Performance Security for an amount of 5% of the order value.
