**Terms & Conditions:**

1. The last date for receiving the quotation in the prescribed form at this office is 06-09-2016 at 12.30 p.m. and the auction will be at 2.30 p.m. on the same day in the presence of such tenders who choose to be present in the office at that time.
2. The tenders should be accompanied by an Earnest Money Deposit of Rs.1000/- in the form of DD drawn in DD in favour of ICAR Unit, CPCRI (RS), and Payable at Kayamkulam for entire quoted trees. The EMD shall be refunded only after the entire tender process is completed. In case the bidder desires to participate both in Auction as well as tender, he shall submit the EMD for the required amount to this auction committee instead of enclosing with the sealed tender.
3. The successful contractor shall cut the trees including removal of stumps and roots of the trees from this Regional Station. The contractor shall also ensure backfilling to required compaction whenever the trees have been removed.
4. The rate should be quoted separately for each tree. The highest rate offered in the quotation only shall be considered for acceptance.
5. Any loss or damage, etc., caused to the Institute properties while lifting the article should be made good or else necessary action will be initiated to recover the same
6. The required implements for carrying out the above works should be brought by the contractor at his own cost.
7. The contractor will have to deposit the entire cost of Tree offered for sale, within 3 days from the date of receipt of communication to that effect and the Tree should be cut and removed from the campus within 3 days thereafter, failing which the EMD shall stand forfeited.
8. The successful bidder shall also remit to this office Sales Tax @ 14.5% of the bid amount, and Forest Development Tax @ 5% of the bid amount + sales tax of 14.5%.
9. Loading, handling, labour and transportation shall be the sole responsibility of the contractor at his/her own cost, during the prescribed working hours of the Institute. No deliveries shall be affected during Sunday or Holiday

10. The successful bidder shall be responsible for any damage that may be done to the Premises while removing the goods by him. The Head, CPCRI, Kayamkulam may at his own options as to make good such damagers and buyer shall have to pay for the same on demand.
