Spraying should be under taken immediately after the 1st round of hand weeding. Note: Chemicals will be provided by the department, whereas fuel and sprayer etc should be brought by the contractor. 1. No implements will be provided departmentally ,Tractor Power tiller charges will be collected, if engaged.

5. A Security Deposit that is equal to 5% of the total amount involved for the work is to be deposited before commencement of work.
