The interested bidders should deposit earnest money deposit through Demand Draft only. The DD may be drawn in favour of "**ICAR UNIT, CPCRI, KASARAGOD**" payable at **KASARAGOD**. The DD along with quotation in sealed covers should reach this office on or before 12.00 noon on the same day. No tender will be accepted after the due date/time. Public auction will commence at 12.30 noon on 18-10-2016 and tenders will be opened after the auction in the presence of available tenderers. The DD of EMD would be returned to the unsuccessful bidders only through registered post to concerned addresses and it will not be returned by hand at any cost on the same day. The transfer and adjustment of EMD/DD from one bidder to another will not be allowed. In the auction hall all the bidders should maintain the discipline till the completion of auction. The bidders should not move from their seat during the time of auction without prior permission of the Competent Authority. A copy of PAN and TIN may be produced by bidders while participating in the auction.

The successful bidders will have to pay **25%** of the bid amount immediately after the auction and the balance in full within seven days of confirmation after clearing the sales tax/market fee on sales etc. to the concerned department in addition to the bid amount, failing which the EMD and **25%** of bid amount will be forfeited and auction will be treated as cancelled.
