Those who have submitted their sealed tenders can only participate in the public auction. Those bidders who have already submitted their sealed tender along with the EMD will also be considered along with the fresh tenders if any received till 11.11.2016 at 5.00 PM. Those bidders, who are submitting their dully filled tenders within the stipulated time schedule, tokens will be issued from this office and the token holders only will be allowed to participate in the public auction. Public auction will be commencing at 11.00 AM on 15-11-2016 and tenders received prior to commencement of the Public auction will be opened after the public auction process is over.

**The EMD will be refunded to those unsuccessful bidders after the proceedings of the auction.** The successful bidders will have to pay the bid amount and sales tax etc. in full and to remove the unserviceable articles within a week of confirmation.

**Terms & Conditions:**


