Sealed cover containing quotation together with DD (EMD) should reach this office on or before 12.00 noon on the same day. No tender will be accepted after the due date/time. Those who have submitted sealed tenders & EMD only can participate in the public auction.

Public auction will commence at **12.30 PM on 02.01.2018** and tenders will be opened after the auction in the presence of available tenderers. EMD in respect of unsuccessful bidders will be refunded only after due process in the office and will not be returned by hand at any cost on the same day. Transfer or adjustment of EMD/DD from the bidders to another will not be allowed. A copy of PAN and TIN may be produced by bidders while participating in the auction.

The successful bidder will have to pay **25%** of the bid amount immediately after the auction and the balance in full within seven days of confirmation after clearing the sales tax/market fee on sales etc. to the concerned department in addition to the bid amount, failing which the EMD and **25%** of bid amount will be forfeited and auction treated as cancelled.
