
**Term & Conditions:-**

4. The contractor should obtain certificate of Registration under Contract Labour (Regulation & Abolition Act 1970, from the Regional Labour Commission (Central) Kochi and comply with all the provision of Act.
5. Payment for service contract will be made on completion of work to our satisfaction and submission of pre-receipted bill.

6. The Director of the Institute will be at liberty to forfeit the Performance Security amount in full or part thereof in the event of non-completion of the awarded work and to our dissatisfaction.
7. The Director of the Institute reserves the right to terminate the contract at any time in case of violation of the agreement.
8. The person so provided by the contractor under this contract will not be the employee of the CPCRI and there will be no employer-employee relationship between the CPCRI and the person so engaged by the contractor in the aforesaid services.
