Sealed tenders along with **EMD of Rs.50,000/-** by DD drawn in favour of "ICAR Unit, CPCRI, RS, Vittal" on Syndicate Bank, Vittal should reach the undersigned in separate envelopes by **11.00 AM on 17.12.2019**. Those who have GST registration, APMC licence and remitted EMD can only submit the sealed tender/participate in the Public Auction. **Public auction will commence at 11.30 AM on 17.12.2019** and the tenders will be opened after conclusion of the auction process. **The EMD will be refunded to the unsuccessful bidders within 15 days of the auction. The successful bidder will have to pay 10% of the bid amount immediately after the auction** on confirmation and the balance amount in full with GST @5% within 15 days after clearing the APMC tax @1.5% etc. to the concerned department in addition to the bid amount, failing which the EMD and 10% of the bid amount will be forfeited and auction will be treated as cancelled.
