Sealed quotations are invited for supply of the following items of fertilizer to ICAR-CPCRI Research Centre, Kidu, Nettana PO, Puttur(Tq), DK Dist., as detailed below:

Sl. No.	Item of Fertilizers	Quantity Required
1.	Urea (Neem Coated)	12,000 Kg.
2.	MOP	26,000 Kg
3.	Dolomite Powder (Agriculture grade)	10,000 Kg
4.	Zinc Sulphate	150 Kg

Quotation should confirm to the following conditions:

1. The rates should be quoted per Kilogram and the same be valid for a minimum period of 90 days from the date of receipt of quotation.
2. Complete description, specification of the items with brand quoted should be given.
3. Quotation should clearly indicate the point of supply such as Ex-works, FOR destination dispatch Station, destination etc.
4. Time required for effecting supply upon receipt of supply order should be indicated.
5. The rate of GST etc. if charged extra should be indicated.
6. Payment will be made only after satisfactory receipt of the item(s) by this office. Advance payment will not be entertained.
7. The item(s) ordered should be supplied in a lot. Part supply will not be accepted.
8. Quotation received after the due date will not be accepted.
9. Earnest Money Deposit @ 2% of the quoted amount, if the quote exceeds Rs.1,00,000/- must be furnished in the form of Demand Draft drawn in favour of 'ICAR Unit CPCRI, Kasaragod' payable at SBI, CPCRI Branch, Kasaragod along with the quotation. Deposit at call Receipt of State Bank of India will also be accepted as EMD provided the receipt obtained from the bank is attached with the quotation/tender. Remittance of EMD in any other mode is not acceptable.
10. The last date of receipt of quotation is 17.08.2017.

11. The right to accept or to reject the quotation rests with the Scientist in Charge, ICAR-CPCRI, Research Centre, Kidu, Nettana.
