7. The Director of the Institute reserves the right to terminate the contract at any time in case of violation of the agreement.
8. The person so provided by the contractor under this contract will not be the employee of the CPCRI and there will be no employer-employee relationship between the CPCRI and the person so engaged by the contractor in the aforesaid services.
9. Income Tax will be deducted from the payments due for the work done as per rules.
10. Any misconduct/misbehavior on the part of the person provided by the contractor will not be tolerated and he will have to be replaced immediately.
11. The person provided should maintain discipline in the premises of the Institute.
12. Performance security equivalent to the amount of 5% of the contract value i.e. **Rs.12,188/-** may be furnished in the form of an A/C payee DD/FD or bank Guarantee from the commercial bank in an accepted form (Performance security should remain valid for a period of 60 days beyond date of completion of all statutory and contractual obligation of the contractor)
