Sealed quotations are invited from interested parties for Auction-cum-sale of coconuts available in this Institute as per details given below:



The sealed quotation may be sent to the Head, CPCRI Regional Station, Kayamkulam so as to reach this Office on or before **14.08.2019** at 2.30 PM. The quotation shall be opened after public auction at 2.45 P.M. on the same day itself. Those who are interested to take part in the Auction/ Quotation may inspect the nuts available in the Farm premises during working hours of the Institute after obtaining prior permission from the SIC, Farm/Tech. Officer Farm. Further details, if any required, can be had from the SIC Farm/Tech. Officer (Farm) of this Institute during office hours.

Terms & Conditions:

01. The Auction/Quotation without EMD will be rejected.
02. The EMD can be paid by DD only, drawn in favour of "ICAR Unit, CPCRI" payable at Kayamkulam. Those who are interested in both auction and quotation may deposit the EMD before the auction to this Office. However, those desirous of competing in the quotations only, may enclose the DD along with the quotations.
03. The amount quoted should be indicated both in figures and words.
04. The highest rate offered in the Auction/quotation shall be considered for acceptance.
05. The successful bidder on award of work shall have to remit 10% of the bid amount in the form of a DD in favour of ICAR Unit CPCRI, Kayamkulam. The EMD shall be refunded once the security deposit is received.
06. The Head of the station reserves the right to accept or reject any quotation without assigning any reason whatsoever; no claim on this account will be entertained in any case.
07. In the event of accepting the quotation/auction price, the purchaser will have to deposit the entire cost of nuts offered for sale by DD, drawn in favour of "ICAR Unit, CPCRI" payable at Kayamkulam within 3 days from the date of receipt of communication to that effect and the nuts should be lifted from the station premises within 3 days, failing which the EMD shall stand forfeited..
08. The bidder who wishes to participate in the sale may quote the amount for the entire quantity of the item of article mentioned above.
09. The rate quoted will be valid only for the particular Quotation.
10. The sealed tenders will be opened after auction, in the presence of tenderers on the date of auction.
11. Any loss or damage, etc., caused to the Institute properties while lifting the article should be made good or else necessary action will be initiated to recover the same.
12. The successful bidder may electronically transfer the cost of coconuts (if he desire so to "ICAR-CPCRI(RS), Kayamkulam") from his bank account . Transferring the amount from a third party shall not be accepted.
13. The Head of the Institute reserves the power to cancel the quotation at any time in case of violation of agreement.
14. If there any sort of strikes etc. the opening of quotations will be conducted the next working day of the notified date.
15. Overwriting or alternations will disqualify the bid unless these are legible and attested by bidder.

16. The Head of the Institute will be at the liberty to forfeit the EMD amount in full or part, thereof in the event of not lifting the nuts within the prescribed period.
