
TENDER-CUM-AUCTION NOTICE

The DD along with quotation in sealed covers should reach this office on or before 11.00 AM on the same day. No tender will be accepted after the due date/time. Public auction will commence at 12.00 PM on **29-09-2015** and tenders will be opened after the auction in the presence of available tenderers. The DD of EMD would be returned to the unsuccessful bidders only by the registered post to concerned bidder addressess and it will not be return by hand at any cost on the same day. The transfer and adjustment of EMD/DD from one bidder to another will not be allowed. In the auction hall all the bidders should maintain the discipline still the completion of auction. The bidders should not move from their seat during the time of auction without prior permission of the Competent Authority. A copy of PAN and TIN may be produced by bidders while participating in the auction.
