

Sealed tenders along with EMD of Rs.2000/- by DD/Pay Order drawn in favour of ICAR unit, CPCRI, Kasaragod and payable at CPCRI, Kasaragod should reach the undersigned by 4.30 PM on 06-8-2018. Those who have submitted their sealed tenders can only participate in the Public Auction. Public auction will commence at 11.00 AM on 08-8-2018 and the closed tenders will be opened after conclusion of the auction process. **The EMD will be refunded to the unsuccessful bidders through NEFT after completing all the auction process.** The successful bidders will have to pay the bid amount and the GST rates in full to remove the unserviceable articles within a week of confirmation.

Terms & Conditions:

Interested bidders are allowed to offer the rate (lot wise) only on payment of Rs.2000/- as EMD, which will be refunded through NEFT after completing all the auction process.

1. The successful bidders should lift the articles after payment of bid amount & GST rate 18% in full within seven days of auction, failing which the EMD made by him will be forfeited.
