Sealed tenders and the **EMD of Rs.5,000/-** by DD drawn in favour of **"ICAR Unit, CPCRI RS, Vittal" on Syndicate Bank, Vittal** should reach the undersigned in a separate envelopes by **12.30 PM on 07.03.2020**. Those who have submitted their sealed tenders & EMD can only participate in the Public Auction. Public auction will commence at **2.30 PM on 07.03.2020** and the tenders will be opened after conclusion of the auction process. The EMD will be refunded to the unsuccessful bidders within one week after the proceedings of the auction. APMC license holders and who have GST registration certificate are permitted to participate in the auction. Copy of GST registration certificate and APMC license should be submitted alongwith tender. **The successful bidders will have to pay 10% of the bid amount immediately** after the auction and the balance in full within a week of confirmation after clearing the APMC tax etc. to the concerned department in addition to the bid amount failing which the EMD and the 10% of the bid amount remitted will be forfeited and auction will be treated as cancelled.
