Sealed bids are hereby invited for the disposal of Tata Sumo (2 Nos) by the Head,CPCRI Regional Station, Krishnapuram, Kayamkulam on as is where is condition. The terms and conditions are as given below:-

TERMS AND CONDITIONS

1. Bid should be submitted in sealed cover super-scribed as "bid for the disposal of" Tata Sumo" due on 05.08.2014 The bid should be addressed to the Head, CPCRI Regional Station, Krishnapuram, (PO), Kayamkulam-690 533 on or before 05.08.2014 by 4.00 p.m. This office shall not be responsible for any delay in postal transit. No bid shall be accepted after the due date and time. If the due date is declared as Government Holiday, the bid due date will be next working day at the same time noticed as above.
2. Bid should be signed by bidder/himself/themselves or a person duly authorized in this behalf. A copy of such authority should be enclosed along with the offer.
3. Bid forms are not transferable.
4. Bid will be opened on 10.08.2015 at 11.30 a.m. If the date of opening of bids happen to be holiday, then the bids shall be opened on the next working day at the same time.
5. Bidders can inspect the present condition of Tata Sumo (as and where it is basis) during office hours (09.30 am to 4.00 pm) at the above mentioned address from 25.07.2015 to 30.07.2015 and satisfy themselves before submitting their offer by the date and time specified above.
6. The bidder may quote their bid both in figures and words. Overwriting or alterations will disqualify the bid unless these are legible and duly attested by bidder/bidders.
7. Rates should be kept valid for acceptance at least for 90 days from the date of opening.
8. The sales tax & other levy if any, will have to be paid by the successful bidder.
9. Earnest Money deposit (EMD): the bid should be accompanied by an earnest money of Rs.5000/- in the form of Demand Draft drawn in favour of ICAR Unit, CPCRI (RS) payable at Kayamkulam.
10. It will be presumed that the bidders before submitting the offer have read all the terms and conditions carefully and accepted the same in full. Deviations from the terms and conditions as given in this notice are not permitted. Any such conditional bid and/or telegraphic bid is liable to be rejected and no alterations shall be allowed after the bid is submitted. No counter terms and condition shall be accepted.
11. Right to include any other conditions or modify or alter any of bid conditions already stipulated is reserved on the Head, CPCRI, Kayamkulam
12. Bidder will be deemed to have been on the clear understanding that they have satisfied themselves full in regard to the present conditions of the Tata Sumo proposed to be auctioned.

13. PAYMENT AND DELIVERIES

- The successful bidder will be required to make full payment of bid by bank draft drawn on any nationalized bank in favour of ICAR Unit, CPCRI payable at Kayamkulam within two days thereafter. Earnest Money Deposit shall be forfeited if the offer is withdrawn during the validity period.
 - The successful bidder will have to lift the Tata Sumo within two days after depositing the full bid amount as per terms and conditions of the bid. Delivery of the vehicle shall be affected against receipt of payment by DD. Any purchaser failing to lift the material within the above stipulated period, shall have to pay ground rent @ 10% of tendered value per week. The Institute will not be responsible for any loss or damage of the Tata Sumo.
 - Earnest money deposited shall be forfeited if any purchaser fails to lift the items after making full payment and expiry of period as mentioned above. Thereafter CPCRI shall be entitled to resell these items. No notice shall be issued to the bidder in this regard.
1. The Purchaser will not be entitled to resell any or Tata Sumo while, they are still lying within the premises of CPCRI and no delivery would be affected by CPCRI to any person or persons other than the purchaser/purchasers whose name /names are mentioned in the delivery order.
 2. The successful bidder before lifting the Tata Sumo should contact the Officer in charge Vehicle, CPCRI, Kayamkulam to get the gate pass and delivery of Tata Sumo.
 3. Loading, handling, labour and transportation shall be the sole responsibility of the successful bidder at his/her own cost.
 4. Loading and lifting of the Tata Sumo shall be done by the successful bidder only during the prescribed working hours of the Institute and no delivery shall be affected during Sunday or Holiday.
 5. The Head, CPCRI, Kayamkulam reserve the right to accept or reject any or all offer/bids either in full or in part without assigning any reason whatsoever.
 6. If, sufficient bids are not received, the Head, CPCRI, Kayamkulam reserves the right to call for fresh bids. In such an event Earnest Money deposited by the bidder shall be refunded.
 7. After lifting of the vehicles, the Earnest Money deposited by the successful bidder shall be refunded in full without any interest.
 8. The successful bidder shall be responsible for any damage caused to the premises while removing the vehicle by him. The Head, CPCRI, Kayamkulam may at his own options, ask to make good such damages and buyer shall have to pay for the same on demand.
